



Announcement of the Bangkok Metropolitan Administration (BMA)
Subject: Order of Temporary Closure of Premises (No. 31)

Reference is made to the Announcement of the Bangkok Metropolitan Administration (BMA) on Order of Temporary Closure of Premises (No. 29) dated 16th May 2021, which premises shall be temporarily closed and enforced with measures as stated in the Announcement of the Bangkok Metropolitan Administration (BMA) on Order of Temporary Closure of Premises (No. 25) dated 25th April 2021 and (No. 26) dated 30th April 2021 until 31st May 2021.

In order to have the disease prevention and control in the maximum and strict control area in compliance with the Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 23) dated 15th May 2021, by the virtue of Section 35 (1) of the Communicable Diseases Act B.E. 2558 (2015), and Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 20) dated 16th April 2021, (No.22) dated 29th April 2021 and (No.23) dated 15th May 2021, Governor of Bangkok, with the approval of the BMA Communicable Diseases Committee as stated in the Meeting Resolution No. 16/2564 dated 1st June 2021, shall have the order as follows;

1. Premises as stated in the Announcement of the Bangkok Metropolitan Administration (BMA) on Order of Temporary Closure of Premises (No. 25) dated 25th April 2021, (No. 26) dated 30th April 2021, and (No. 29) dated 16th May 2021 shall be temporarily closed and enforced with measures;

2. In case where the Announcement of the Bangkok Metropolitan Administration (BMA) on Order of Temporary Closure of Premises (No. 25) dated 25th April 2021 is contrary or inconsistent with (No. 26) dated 30th April 2021, the latter Announcement shall have overriding effects over the previous one, and in case where the said two Announcements are contrary or inconsistent with (No. 29) dated 16th May 2021, the latter Announcement shall have overriding effects over the two previous ones.

Any persons who violate or fail to comply with this Order shall be guilty of an offense under Section 52 of the Communicable Diseases Act B.E. 2558 (2015) which shall be liable to imprisonment for a term not exceeding one year or to a fine not exceeding one hundred thousand Baht or to both and shall be guilty of an offense under Section 18 of the Emergency Decree on Public Administration in Emergency Situation B.E. 2548 (2005) which shall be liable to imprisonment for a term not exceeding two years or to a fine not exceeding forty thousand Baht or to both.

As this is a case where there is urgent necessity and the delay of action may cause great harm to any individual or affect the public interest, litigants shall not be given the right to object under section 30 paragraph two (1) of the Administrative Procedure Act, B.E. 2539 (1996).

This Order shall take effect from 1st June 2021 until 14th June 2021.
